## Status of PVARC public events

As of the time this **QRO** issue is being finalized the 2020 Palos Verdes Half Marathon is still scheduled for Saturday, November 21, along the Peninsula's coastline. # Proposed RPV antenna ordinance makes several changes but...

The Rancho Palos Verdes Planning Commission's August 25 meeting continued until September 22 further discussion of proposed amendments to the city's non-commercial (amateur) radio antenna code. This continuance followed a second version of the proposed amendments that was issued in the week prior to the August 25 Planning Commission meeting.

Among changes made in the second version are:

- ◆ Lattice antenna towers (which comprise most of today's amateur radio towers) would be allowed, after having been banned in the initial proposed amendments.
- ◆ Antenna guy wires (also banned in the initial proposed amendments) would be permitted if they help reduce the visual impact of an antenna structure, i.e., a more slender tower.
- ◆ The maximum height for a "by-right" no-permit antenna was restored to the current 16' above ground from a proposed reduction to 12'. A "by-right" roof-mounted antenna can extend up to 12' above a home's roof.
- ◆ Instead of requiring a costly exact mock-up of the antenna structure certified for safety by a licensed structural engineer for neighborhood review as stated in the original code amendments the revised draft would allow antenna applicants to submit photo simulations of the antenna structure and antenna as they would appear on the property.

Some major problems still in the second draft are requirements to always lower towers to minimum height when not in use (although it's not practical for lift cables to be continually retracted and extended)—and to notify all property owners within a 500' radius for any antenna over 16'. The PVARC Board of Directors believes the existing RPV non-commercial antenna ordinance developed in 1999 has served well in balancing the needs of amateur radio operators, nearby residents, and the city. We urge retention of the current ordinance that resulted from a collaborative effort of several knowledgeable PVARC members residing in Rancho Palos Verdes, the City's Director of Community Development, and resident input.

The latest draft of the proposed antenna ordinance is not on the City's website but is available to interested parties. ■

# WSPR—one-way ham radio

(. . . a whisper from beyond the horizon . . . will it be heard?)

Weak Signal Propagation Reporter (WSPR, pronounced “whisper”) is an amateur radio digital application released in 2008 by Joe Taylor, K1JT, co-developer of FT8, FT4, JT65 and several other modes within the WSJT-X suite of amateur radio digital modes. Signals from WSPR beacon transmitters around the world, often emitting very low power (as little as a few milliwatts), are received and reported by other hams around the world. The objective is to map out potential propagation paths that exist on the various amateur bands throughout the day and night. If you have the WSJT-X digital modes suite already downloaded and installed on your desktop or laptop computer attached to your radio, then you too can report hearing the beacon transmitters of other ham stations around the world. This article will focus on receiving and reporting the reception of these beacons. But, it will also demonstrate how to easily and quickly turn one’s own HF transmitter into a low-power WSPR beacon. A **QRO** newsletter article in a later issue will discuss how to build a dedicated beacon transmitter so that you can determine how well your own low-power signal is being received by hams around the world and not tie up your main HF transceiver doing so.

## Background

WSPR was originally conceived by Nobel Laureate Dr. Joseph Taylor, former Princeton University physics professor and Faculty Dean. A ham operator from an early age, Joe had a strong interest in weak signal detection in which signals are significantly weaker than the ambient noise in which they are embedded, i.e., where signal-to-noise ratio (SNR) is much less than one, or  $\ll 0\text{dB}$ . He was intrigued by the notion of passing short messages using non-traditional radio communications methods, such as moon-bounce and meteor scatter, and wanted to exploit making extremely long-distance contacts using very low power transmissions [1].

WSPR was first released in 2008 as a separate stand-alone application. But, in 2015 after FT8, JT65 and other digital modes already had been assembled into a downloadable suite of applications, WSPR was finally included in that suite. The latest version (currently v2.2.2) of the WSJT-X digital modes suite can be downloaded from: <https://physics.princeton.edu/pulsar/K1JT/wsjitx.html> [2].

The standard WSPR message is quite simple, just three parts: callsign, 4-character Maidenhead grid square locator and transmitter power level in dBmW. That adds up to 50 bits: 28 allocated to callsign, 15 for locator and 7 for power level. For transmission robustness, a convolutional code for forward error correction is added, turning those 50 bits into 162 bits, including bit redundancy. Those 162 bits are transmitted at the very slow rate of just under 1.5 bits per second—1.4648 bps, to be exact. Modulation of a given ham band’s RF carrier is 4-frequency shift keying (4-FSK), meaning that from symbol to symbol the outgoing frequency will shift among four separate frequencies (spaced  $\sim 1.5$  Hz apart) so the entire signal bandwidth from an individual station is a mere 6 Hz. Hence, a lot of stations can fit into and share the 200 Hz sub-band that is allocated for WSPR on each ham band. Going back to bit rate, 162 bits divided by 1.4648 bps equals 110.6 seconds. Since each transmission takes just under two minutes to complete, cycle time for WSPR transmissions is set to exactly 2 minutes. Transmissions start one second into an even UTC minute, e.g., 23:54:01, then 23:56:01, etc. As in FT8 and other digital modes, an accurate clock is essential (generally  $<1$  second error) [3][4].

While WSPR is most useful on typical “over-the-horizon” HF bands, it has also been used on VHF and UHF bands, most notably for alerting amateurs about the rare occurrence of tropospheric ducting and tropospheric scatter when over-the-horizon communication in these bands is possible [5][6]. Conditions that govern this phenomenon are driven by large-area temperature inversions that occur primarily in late spring and early summer. Ducting paths can form for just a few hours to a week at a time. Inversion thickness determines the frequency most likely to refract [7]. Well-known Hawaiian CW beacon station KH6HME installed WSPR capability on 70 centimeters in 2017 and 2 meters in April 2020 [8]. Stateside VHF/UHF DX enthusiasts monitor that beacon for early warning of when these rare DX opportunities occur.

**Caveat:** Because of WSPR's development history (i.e., standalone app in 2008, but integrated into the WSJT-X suite in 2015), many of the instructions, personal postings and YouTube videos created prior to 2015 are somewhat obsolete or different in appearance relative to the WSJT-X version of WSPR. So, it's important to note the posting dates of materials found on the Internet to avoid confusion and to make sure they're still relevant for your needs.

### Getting started—copy and report other hams' beacons

Start by downloading the latest WSJT-X digital modes suite (URL cited above)—unless you're already using this suite for other digital modes such as FT8, FT4 and JT65. Instructions for installing and using the assortment of digital modes in this suite, including WSPR, are available online [9]. This article does not attempt to provide WSJT-X setup instructions, as there are individual decisions to be made related to the operator's radio model, sound card selection, etc. Quick-start guides and detailed manuals are available to ensure successful initial setup. The universal serial bus cabling (or Ethernet connection in the case of Flex Radio) between the radio receiving the WSPR signals and the computer processing the data, as well as any required transmit-enable (PTT) and receive-audio cables, are assumed to be connected and functioning properly. [If not, return to the appropriate manual(s) for troubleshooting instructions.]

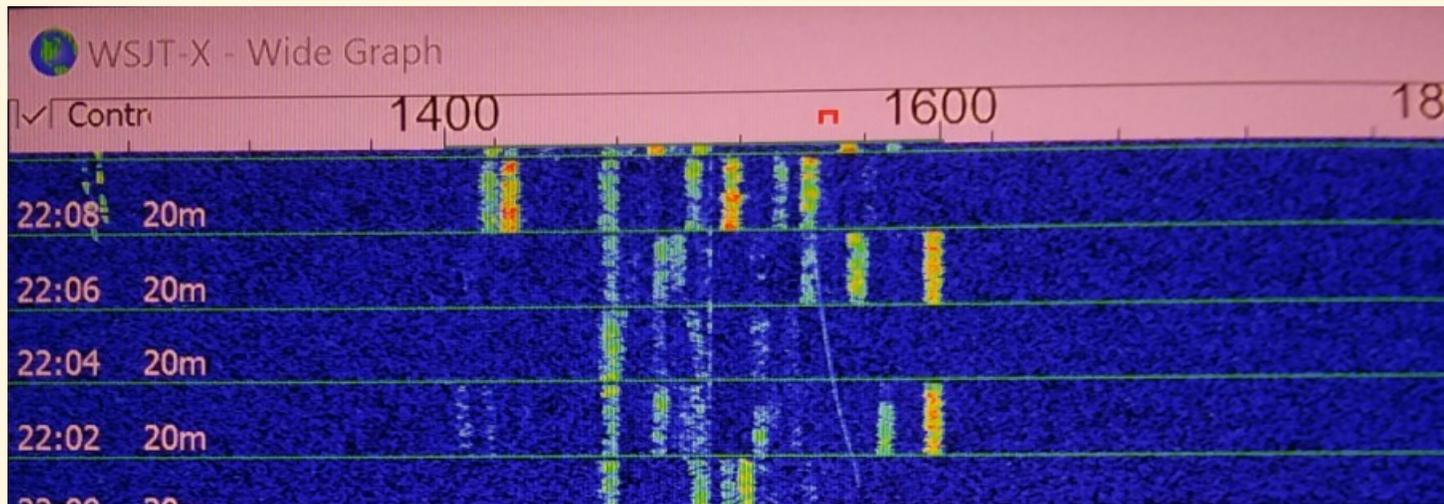
**Figure 1.** Wide Graph footer section in WSJT-X, with parameters specifically selected to properly display WSPR.

Open the WSJT-X suite and position the two display windows to your liking on the computer screen. Since you'll be interested first in determining if you can copy WSPR beacon stations, set the radio on an active band; generally 20m is very active during daylight hours. The receiver dial frequency for 20m is set to exactly 14.095600 MHz. Configure the radio mode to be upper sideband and set bandwidth for 2.5 kHz. (Note: upper sideband is used for WSPR on all bands, not just 20m and higher.) (Note: For Flex radio users, the mode selected is "DIGU," same as for other digital modes like FT8.) In the menu header of the main WSJT-X display window, select Mode as WSPR. Then set the Wide Graph footer section to the parameters shown in Figure 1. (These parameter values work well for WSPR but aren't the best values for FT8, so remember to set them to match the values appropriate for each digital mode [Ref. 9, sections 6.6 and 9]).

Within a few minutes (remember that just one receive cycle takes two minutes), you'll begin to see the Wide Graph region populate with beacon signals, as shown in Figure 2. Each of these vertical lines of width ~6 Hz represents a separate beacon transmission of a little less than 2 minutes in duration. All beacon signals will fall inside the 200 Hz window centered on 1500 Hz in the display. Recall that the radio's upper sideband receive bandwidth has been set to 2500 Hz, so these WSPR signals will fall well inside this band.

**Figure 2.** Each vertical segment represents a beacon transmission that lasts for just shy of 2 minutes. Most beacon stations choose to transmit for much less than half the time. (Joe Taylor recommends 20% of the time in transmit mode and 80% in receive mode.) UTC in hh:mm format and ham band are shown on the left side of the window. The little red “inverted u” to the left of 1600 is the transmit frequency indicator that should be set to an unoccupied region in the 200 Hz-wide window in the Wide Graph (to avoid QRM) if it is decided to transmit, not just receive (more about that in the next section).

In addition to seeing the signals displayed in the Wide Graph region, there will be (usually) numerous entries in the main display window, as illustrated in Figure 3.

**Figure 3.** Display of just some of the 20m beacon stations heard at UTC 2300 at receiving station NG6R. Like other digital modes such as FT8 and FT4, the “dB” column shows the SNR of each station as calculated by WSJT-X software at receiver station NG6R. “DT” reflects the difference (in seconds) between the clocks of each beacon station and the clock at NG6R. Note the one station (AG5DB) with a DT of 1.3 seconds and yet the signal was decoded even though the timing difference was greater than 1 second. (What isn’t known, of course, is how many stations with DT even greater than this value were not decoded.) The receive frequencies are not tied to fixed slots, but instead reflect a choice made by the beacon station operator. Note that although the beacon station at 14.097147 (AG5DB) is only 2 Hz away from the station at 14.097149 (KI7DX) (so that the two stations actually overlap their 6 Hz-wide signal bandwidths), they are still decoded with ease. This speaks highly about the convolutional coding inherent in each signal and the ability of the WSPR decoding algorithm to pull signals not only out of noise but out of digital QRM as well. “Drift” is measured in Hz/minute and is usually a small number like 1 or 2, often zero, as crystal oscillators in modern rigs are quite stable. Recall that the next three parameters: Call, Grid and dBm are data coming directly from the beacon stations’ coded messages. Since Tx power is in dBm, a value of 37 represents 5W, 23 represents 200mW, etc. (Recall that 0dBm=1mW, 10dBm=10mW, 20dBm=100mW, 30dBm=1W and 40dBm=10W.) The “mi” column reflects the software’s calculation of reporting stations’ separation distance based on mean grid square differences from NG6R’s QTH, expressed in statute miles.

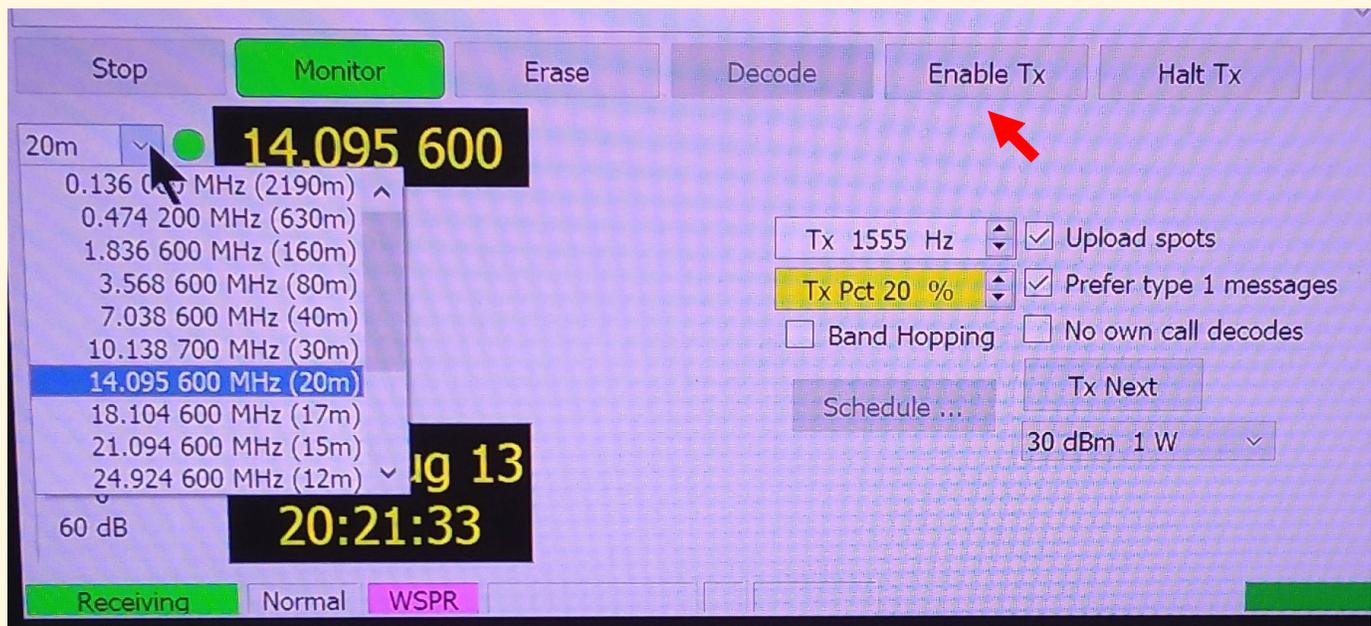

Having successfully received, decoded and displayed numerous WSPR beacon stations, let's now examine the ease with which we can turn our own station into a WSPR transmit beacon.

### Create your own transmit beacon station

The procedure for adding transmit capability to our already successful beacon-receive station is very simple. First adjust the radio's transmit power level to a very low setting. There is no output power setting on the Flex radio between zero and one watt, as power settings are only in one-watt increments. So the radio transmit power at station NG6R is set to 1 watt or 30dBm. If your radio permits even lower output power settings, choose a suitably low setting and note the power output, which will be entered into the main WSPR window footer, as discussed below.

With WSJT-X in Mode WSPR, go to the lower left corner of the main display footer and click on the band select window, as illustrated in Figure 4.



**Figure 4.** Left portion of WSJT-X main display footer showing band selection window highlighted on the left.

You'll see a standard set of pre-loaded WSPR frequencies for all HF (as well as LF, MF, VHF and UHF) bands. These are the frequencies that are to be dialed into the radio receiver, which is set in upper sideband mode with a 2.5 kHz bandwidth. Note in Figure 4, the 20m frequency of 14.095600 MHz is highlighted.

Now, look at the right side of Figure 4. The "Tx 1555 Hz" indicates that the little red "inverted u" shown in the upper portion of Figure 2 is currently set to 1555 Hz up from the receiver dial frequency of 14.095600 MHz. This is where our transmit signal will be positioned, i.e.,  $14.095600 + 0.001555 = 14.097155$  MHz. This Tx position was chosen to generally stay clear of all other beacons we could see operating in the band at the time. This QRM-avoidance technique will look familiar to experienced FT8 and FT4 users.

For general WSPR operation, the percentage of time spent transmitting should be significantly less than time spent receiving (K1JT recommends 20/80), but this is a parameter that can be set, as shown in Figure 4. Note that NG6R output power is selected from the pull-down menu to be 30dBm or 1W.

There is just one more step in becoming a WSPR transmit beacon—click on the box in Figure 4 labeled Enable Tx. It will turn red and thus place your transceiver in an “on-the-air” condition for whenever the software algorithm determines it’s your turn to transmit. There is a certain amount of seeming “randomness” in which 2-minute interval your transmitter will automatically activate, especially if the percentage of Tx time does not result in a consistent transmit periodicity. But at a Tx Pct setting of 20%, your transmissions should occur generally every fifth 2-minute interval. For the other four 2-minute intervals, your transceiver will operate in receive mode.

### Displaying the results

There is another very important feature of WSPR that is actually captured via a separate website called [wspnnet.org](http://wspnnet.org) [10]. It has maps with adjustable size and can create a database of reports based on settable parameters. Figure 5 shows a small sampling of WSPR stations that received NG6R’s 1-watt transmission at 23:56Z on 11 Aug 2020.

**Figure 5.** A small sampling of the 70+ worldwide reports posted on [wspnnet.org](http://wspnnet.org) after just one 2-minute WSPR transmission by NG6R at 2356Z on 11 Aug 2020. The Flex radio was set for 1 watt output power and the antenna was the hex beam at 30’ height pointed toward Europe (35 degrees Az). Note the Great Britain (G8) station at -20dB signal-to-noise relative to a reference 2.5 kHz bandwidth. Since -28dB SNR (sometimes even lower) is possible in WSPR, a power of approximately one-tenth of NG6R’s 1-watt output power (i.e., 100mW) might have been reported by this station—Europe on ~100mW!!

Note that the “SNR” values in Figure 5 represent what was reported by the respective receiving stations. How did [wspnnet.org](http://wspnnet.org) get these data values? Look back at the right side of Figure 4 and note that the “Upload spots” box is checked. Checking that box means that a WSPR receiving station’s data will be continually forwarded via the Internet to [wspnnet.org](http://wspnnet.org) for analysis and display.

Another great feature of the [wspnnet.org](http://wspnnet.org) website is the availability of maps, which can display stations that you hear, stations that hear you, or both, depending on configurable settings. Figure 6 shows the stations that heard NG6R’s 1-watt WSPR signal, late afternoon local, with the 20m antenna generally directed toward the northeast.

Some WSPR users have exploited this propagation reporting asset to compare different antenna configurations or the same antenna under different conditions [11]. In this scenario, “Tx Pct” could be set to 100%, as you would want to acquire the A-versus-B configuration data as quickly as possible. Antenna A (or condition A) would be run for, say, 10 minutes (or even as little as just one 2-minute cycle); then antenna B (or condition B) would be run for the same period of time. Then, count up the number and examine the locations of stations reporting receipt of your signals (complete with SNR levels), and compare them to see which antenna configuration (or condition) is better suited to meet your objectives.

## Solar Minimum Most Likely Occurred in December 2019

Sunspot Index and Long-Term Solar Observations (SILSO) in Belgium said this month that the minimum between Solar Cycles 24 and 25 “most probably” took place last December. SILSO, a part of the Royal Observatory of Belgium and formerly known as SIDC, cited as evidence the January 2020 increase in the 13-month smoothed sunspot number — the first upswing since the Cycle 24 maximum in April 2014.

“[F]or now, this latest smoothed value in January 2020 is the very first point indicating a rise of the activity. So, the date of the minimum still needs a full confirmation over the coming months,” SILSO said on its website. “For now, preliminary smoothed values, limited to less than 13 months, hint at increasing values over coming months. If the rising trend indeed continues, this [December 2019] date will become fully definitive.”

SILSO said another indication of the transition between the two solar cycles can be drawn from counting individual sunspot groups that belong to either the old or new solar cycle. “While most sunspot groups belonged to the last solar cycle [Cycle 24] until September 2019, the dominance switched to groups of the new cycle in November 2019,” SILSO said.

SILSO said that in terms of the number of active regions, the minimum between Cycle 24 and Cycle 25 falls in October 2019. “This is close to December 2019,” SILSO said. It attributes the difference to three factors:

- The sunspot number also takes into account the total number of spots, and thus the size of the emerging active regions.
- The time of the minimum depends on the respective trends of the declining phase of the past cycle, and of the rising phase of the new cycles, over the 12 months surrounding the minimum.
- The date of the minimum has a significant uncertainty range. Near minimum the activity hardly varies and is close to minimum during a few months. “The date of the minimum is thus always less sharply defined than the date of the maximum of the cycles, which are more sharply peaked,” SILSO explained.

“This late-breaking upward trend is now expected to accelerate over the coming months,” SILSO predicted. “So be prepared for a more eruptive and interesting sun!” ■

The ARRL is the only national organization representing amateur radio and has another significance for the PVARC: We receive benefits from being an ARRL-affiliated club. But an ARRL-affiliated club requires at least 51% of club members also be ARRL members.

Annual ARRL membership costs \$49 and includes your choice of the printed monthly **QST** magazine or the ARRL's new **On The Air** magazine for newer hams. Both are available electronically to all ARRL members plus a new member benefit: free online access to ARRL's two other publications, **QEX** and **National Contest Journal**.
